2. **THIS COURT ORDERS** that the Office of the Public Guardian and Trustee, Ontario, and the Public Guardian and Trustee of British Columbia shall retain, use, and dispose of the Class Counsel Contact List in accordance with the terms of the ISA;

3. **THIS COURT ORDERS** that the disclosure of the Class Counsel Contact List by Class Counsel to the Office of the Public Guardian and Trustee, Ontario, and the Public Guardian and Trustee of British Columbia comply with Class Counsel's obligations under the *Personal Information Protection and Electronic Documents Act*, S.C. 2000, c. 25, and its Schedules.

4. **THIS COURT ORDERS** that there shall be no costs of this motion.
